The Director informed the Members that on 27th July 2019, at 3 pm all the Senior Batch Students along with Faculty Members were asked to assemble in the Seminar Room on the Fourth Floor. The main purpose was to educate the students on Prevention of Ragging. He explained that ragging includes conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a 1st Year Student or any other student. Such an act should be strictly avoided and any such cases faced by the student should immediately be reported to the Anti-Ragging Committee.

It was decided by all members that the following points will be

adopted in order to prevent ragging in the institute:

- The Institution shall tighten security in its premises, especially at the vulnerable places. If necessary, intense policing shall be resorted to at such points at odd hours during the early months of the academic session for prevention of ragging.
- The institution will engage or seek the assistance of professional counselors to counsel Students in order to prepare them for the life ahead.
- The institute will inform the 1st Year Batch of Students about their rights as students of the institution and clearly instruct them that they should desist from doing anything against their will even if ordered by the seniors, and that they have nothing to fear as the institution cares for them and shall not tolerate any atrocities against them.
- 1st Year students shall be encouraged to report incidents of ragging, either as victims, or even as witnesses.
- Anonymous random surveys shall be conducted across the 1st year Batch of students every fortnight during the first three months of the academic year to verify and cross-check whether the campus is indeed free of ragging or not.
- The college canteen is also a place where ragging often takes place, hence the employers/employees of the canteen shall be given necessary instructions to keep strict vigil and to report the incidents of ragging to the college authorities, if any.
- First Year Students welcome parties shall be organized by the senior students and the faculty together soon after admissions, for proper introductory sessions between them. This will be an interactive session and active care will be taken to prohibit ragging.
